

Terms & Conditions

for Samsung free installation promotion

These Terms and Conditions will govern your participation in the Samsung Free Installation Promotion ("Promotion"). You are deemed to have read and consented to these terms and conditions prior to entering into this Promotion. Please refer to this website for the current Terms and Conditions for the Promotion. All participants during the term of the Promotion agree to be bound by the following terms and conditions:

1. The Organizer of the Promotion is Samsung Electronics South Africa (Proprietary) Limited, Registration number: 1994/003872/07 and/or its agencies and Fourways Air-conditioning Pty Ltd ("Organizers").
2. The Promotion will run from 18 May (00h00) to 30 June 2015 (23h59) ("the Promotion Period"). The duration of the Promotion may be extended or curtailed at the discretion of the Organizers. The promotion is only valid while stock last.
3. To be eligible to participate in this Promotion the participant must:
 1. Be 18 years or older and be a legal resident of South Africa
4. The Promotion will afford the participant a chance to receive a free installation upon purchase of an indoor and outdoor Samsung Room Air Conditioner ranging from a 9000 BTU to a 24000 BTU, subject to stock availability ("Offer")
5. This Offer is only applicable to back to back installation with a 3 metre pipe length, any pipe longer than mentioned length will be for the participants account as quoted by the dealer
6. This Offer is only applicable to purchases from participating accredited dealers as listed on the following website www.fourwaysaircon.co.za
7. This Offer is provided at the sole discretion of the Organizer and is not transferable and may not be substituted or exchanged for cash
8. This Offer is limited to 1700 (one thousand , seven hundred) installations
9. This Offer relates only to aluminum piping and the pipe kits that include brackets
10. All electrical work including electrical isolators are not included in this Offer. There will be no trunking offered for the pipe work. Those would be additional and for the end users account.
